The aim of the society is to promote the cause of education in the area and for this purpose:

- a) to provide, establish, endow, maintain and control and manage schools and other education institutions and to do all acts and things necessary for or conducive to the promotion of education in the area and for this purpose, to start, establish, conduct, maintain and manage classrooms, libraries, laboratories, Gymnasiums, hostels, residential quarters and the like.
- b) For any of the purposes aforesaid, to procure the assistance of qualified staff both voluntary or otherwise.
- c) To solicit, obtain or accept subscriptions, donations grants, gifts, devises, bequests and trusts from any person-firm, corporation or institution.
- d) to acquire ~~xxx~~ by gifts, purchase, exchange, lease or on hire or otherwise, any lands buildings, basements, rights in common, playgrounds, parks and any property moveable and/or immoveable and for any estate or interest for the furtherance of any or all of the aims of the society.
- e) to build, construct and maintain houses or other buildings and alter, extend, improve, repair enlarge or modify the same and to provide, equip the same with light, water drainage, furniture fittings, instruments, apparatus and appliances.

- g) For the purposes aforesaid , to sign , execute, and deliver such assurances and deeds as may be necessary .
- h) To do all such other lawful acts, deeds or things as are incidental or conducive to the attainment of any of the above objectors.
- i) The management of the affairs of the society is entrusted in accordance with the rules and regulations of the society to the Governing council of which the first members are :
